The Sugar Movement Plan for April - 2006 is enclosed.

In the reference 1st cited Government of India have allotted a quantity of **9725.2 Mts** of Levy Sugar on A.P Sugar Factories out 2005-2006 season's production. Out of this, a quantity of **2815.6 Mts** is kept as **reserve.** Thus, a quantity of 6909.6 Mts is taken into account from April allotment of GOI.

A quantity of 2094.5 Mts . which was kept as reserve with Chelluru (1094.5 Mts) and Chagallu (1000.0 Mts) factories, is clubbed to April-2006 allotment. Thus, the total sugar stocks available for the month of April 2006 works out to **9004.1 MTs (6909.6 + 2094.5).**

The factory authorities have confirmed over phone about availability of sugar stocks and ready to deliver stocks on receipt of GOI allotment Therefore, all the District Managers are requested to lift the stocks allotted to their respective districts immediately and ensure that adequate stocks are positioned in all the MLS points.

The District Managers are requested to keep the available stocks over and above CCS allotment as buffer and under any circumstances **the total releases should not exceed CCS allotment**.

The validity period to lift the stocks for April-06 allotment is upto 20-05.2006 whereas for the buffer stocks of March 2006 (stocks of 2094.5 MTs kept as reserve out of March allotment) is upto 19-04 2006 only. As the entire allotment for the month of April is made on the sugar factories located in the State only, all the District Managers are directed to complete their entire lifting by **19.04.2006** positively.

The Dist.Managers of Srikakulam, Vizianagaram, Visakhapatnam and East Godavari may move the stocks departmentally as per the transport rates approved by their respective District Tender Committees for April-2006 allotment also till adhoc contractor is appointed.

All the District Managers are requested to contact the concerned Sugar factory authorities about availability of levy sugar stocks before making payment. If any factory is not delivering sugar on any ground, the matter may be taken up with that sugar factory through the concerned Collector/Joint Collector under copy marked to Head Officem for further necessary action..

The District Managers should not release more than the allotment made by the Commissioner of Civil Supplies and Consumer Affairs, Andhra Pradesh, Hyderabad taking into account the opening balance available with the MLS points and keep the remaining stocks as buffer in the district. The said buffer will be taken into account for next month allotment. Any excess utilization this month would lead to proportionate deficit in next month. Hence, all District Managers must stick to CCS allotment compulsorily for utilizing PDS sugar in April-2006.

All the Dist.Managers and Zonal Managers are requested to immediately work out the arrangements for monitoring the movement of sugar under Stage-I transportation from sugar factories to destination MLS points, consignment-wise on daily basis with immediate effect. They are requested to follow the instructions already issued in Circular No. PDS-5 dt 2-7-2005.

They should send lifting particulars by SMS as per circular No.A&V 20 and 24, and also from the concerned District Manager's office.

The above instructions shall be followed scrupulously with immediate effect.
