WHEREAS, in the reference read above, tentative seniority list of A.M.(Accts.) in terms of APSCSCL Recruitment and service Regulations and as per the Roster and Rule of Reservation was communicated to all officers shown in Annexure enclosed therein calling for objections if any on the tentative seniority list communicated.

**I)** WHEREAS, the following employees have raised objections on placement of their seniority in the tentative seniority list communicated in the reference cited. Details as per record are as follows:

1. Sri A.Ravindranath, AM (Accts.), F&IA Section, H.O.
2. PVS.Mohan Rao, AM (Accts.), DO, Chittoor
3. YVRK.Bharadwaj, AM (Accts.), DO, Vijayawada
4. A.S.Prakasa Rao, AM (Accts.), DO, Adilabad
5. L.Nageswara Rao, AM (Accts.), DO, Vizianagaram

WHEREAS, objection of the above officers is that their seniority is fixed below Sri G.Sudheer Kumar Reddy, Smt.Ch.Kalpana and Sri M.Pratap Reddy whose services were regularised two years later. As such they have requested to place them above the said candidates.

WHEREAS, Government vide G.O.Ms.No.368, Food & Agriculture (CS.III) department, dated has issued orders that all the employees appointed till 30.06.82 on daily wages in the Corporation shall be regularised and placed on monthly wages in relaxation of the executive instructions issued in Govt.Memo.No.1499/Lab.III/60-2, dated 12.08.60 issued under provisions of Employment Act.1959.

Accordingly, the services of employees who were educationally qualified i.e graduates appointed prior to 30.06.1982 and passed the written test were regularised w.e.f 08.10.1982 vide VC& MD Procdgs No.APSECCL/Ett/B1/400/82, Dt.22.07.83

Later the services of employees who had requisite educational qualification i.e graduation appointed prior to 30.06.1982 but who did not pass written test were also regularized vide reference third cited, after placing the matter before the Board in its 14<sup>th</sup> meeting which resolved that all those employees appointed before 30.06.1982 and qualified as per staff regulations be regularized w.e.f 01.03.1984.

Promotions to employees from Acctt.Gr.III to Acctt.Gr.II were effected in both ESCOM (1987, 1988 & 1989) and CSC (1989), after the same, A.P. State Essential Commodities Corporation was merged in Civil Supplies Corporation in the year 1991.

After merger, certain employees filed W.P.No.8216/2003 in the Hon'ble High Court to regularise their services w.e.f.08.10.1982 instead of 01.03.1984 as per the Judgement of Hon'ble Court in WP.No.8189/1986 in which Sri E.Subba Reddy and 11 others non-graduate employees of ESCOM obtained orders on 10.03.1989. The operative part of the judgement is mentioned below :

"All those employees who have been recruited prior to 30.06.1982 would be entitled to have their services regularised with retrospective effect whenever they acquire the necessary qualification by the end of December, 1989".

As the said judgement was confirmed in WP.960/88 and also in WA.No.960/92 in WP.No.5364/98 dated.06.03.2002 in case of Sri T.Madhusudhan and others, the Writ Petition of the employees was allowed by the Hon'ble High Court.

In view of the above judgements, the services of (13) employees were regularised w.e.f.08.10.82 retrospectively in different spells. Details are mentioned below :

WHEREAS, as per the directions of the Hon'ble High Court and objections raised by certain employees to the tentative seniority list, the seniority of all employees given retrospective regularisation was revised as pr their date of original appointment of daily wage.

WHEREAS, upto 1991, there were two Organisations namely A.P. State Essential Commodities Corporation Ltd., and A.P. State Civil Supplies Corporation Ltd., dealing with procurement and distribution of essential commodities. In both Organisations, services of daily wage employees were regularised in terms of above G.O., separately and subsequently promotions were also effected to the cadre of Accountant Grade II on different dates i.e. in ESCOM during the year 1987 , 88 and 89. In CSC, promotions were effected to the cadre of Accountant Grade II during the year 1989 which is clear that the above two sets of employees belonging to ESCOM and CSC were promoted to the cadre of Acctt.Gr.II before the merger of ESCOM into CSC.

WHEREAS, Sri T.N.Koteswara Rao and 9 others (namely V.Rajendra Prasad, M.Pratap Reddy, K.S.R.Murthy, M.Sivasankara Rao, I.Veeraiah, M.Muralidhar, P.Sanjeeva Rao, N.B.Kasim and G.Seshagiri Rao) have filed two (2) W.Ps in Hon'ble High Court praying that

- 1) WP.No.8216 of 2009 : seeking an order or direction, declaring the action of the respondent Corporation in not giving the benefit of regularisation to the petitioners from 08.10.82 and also seeking directions to fix interse seniority among Grade III by reckoning the date of regularisation from 08.10.82 as per GO.Ms.No.368 dt.08.10.1982 and by giving all consequential benefits thereof.
- 2) WP.No.17221 of 2009 : they have challenged the final seniority list of Acctt.Gr.I dated.28.07.2009.

WHEREAS, on 24.07.2012, Hon'ble High Court has given common judgement in W.P.No.8216 of 2003 and 17122 of 2009 which is mentioned below :

*"The problem is far from very simple to find a solution. Now we have two sets of employees in the Corporation. One set is those whose services have been regularised at the first instance through the procdgs., of Managing Director dated.22.07.1983. Their services were regularised w.e.f.08.10.82, the date on which the State Government passed their orders through GO.Ms.No.368. They have also passed the written test/screening test by whatever name it is called, conducted by the Corporation. They are also otherwise fully qualified in the sense that they possesses graduation qualification by 30.06.82, the cut off date prescribed by the State Government in GO.Ms.No.368. Therefore, the set of employees is not at fault in any respect. Their services have been rightly and legitimately regularised w.e.f.08.10.82. Now we have the second set of employees whose services have been regularised on or after 26.07.2004 pursuant to the judgement rendered by this Court in WP.No.8189 of 1986 and WA.No.960 of 1988. Their dates of regularisation, which were accorded earlier as 01.03.84, have been upwardly revised to 08.10.82.*

*This set of later regularised employees, in my opinion, cannot claim any seniority over the earlier set of employees whose services have been regularised through proceedings, dated.22.07.1983, with effect from 08.10.1982. Those whose services have been regularized through proceedings, dt.22.07.1983, have earned a foothold in the services of the Corporation. In their own right, they possess the necessary qualifications and they were all appointed prior to 30.06.1982, the cut off date prescribed by the State Government and they have also passed the written test conducted by the Corporation. Once a person's services have been regularized and those proceedings have not been challenged in any competent Court, one is entitled to sit back and consider that his rights flowing there from have been crystallized. Seniority will be reckoned with effect from the date of regularization of services. Therefore, for all purposes 08.10.1982 will become the relevant date. The first set of employees has already gained that date, entirely on their own. Subsequently regularised employees got the same dates i.e. 08.10.82 by virtue of the resolution passed at the 14<sup>th</sup> Board meeting read with a judgement rendered by this court in WP.No.8189 of 1986 and WA.No.960 of 1988. By virtue of the regularisation of their services, they are entitled to count themselves as regular employees of the Corporation and earn all other benefits but they can not steal a march in the seniority against those whose services are regularised earlier to them.*

*All those candidates who have passed the written test conducted by the Corporation and got their services regularised w.e.f.08.10.982 through the Procdgs., of VC&MD dated.22.07.1983, must en bloc be treated as seniors to those whose services have been regularised subsequently such as through the Procdgs., of VC&MD 26.07.2004, although with effect from the same date namely 08.10.1982 latest seniority list of Assistant Grade III and Accountant Grade III be drawn by the respondent Corporation.*

*Unless a proper finalised seniority is drawn, inter se rights of the candidates will not be determined. The Zonal consideration for the purpose of promotion can not be finalised without finalising the seniority list of Assistant Grade III or Accountant Grade III, as the case may be.*

*Regulation 19 (b) specifies that the promotion to regular or long term vacancies in a post or cadre shall be made on the basis of merit-cum-seniority in accordance with the recommendation made by a Departmental Promotion Committee constituted for this purpose from time to time. I therefore conclude that all promotions in the services of the Corporation are to be made on the basis of merit-cum-seniority but not purely based upon the principle of seniority-cum-fitness or seniority-cum-eligibility. Hence all promotions have got to be made in the services of the Corporation on selection basis.*

*Seniority of the candidate will be a relatively insignificant part in the matter of promotions. Selection posts are essentially filled upon the assessment of the merit made by the Departmental or Promotion Committees. Therefore, if the promotions were already published by the Corporation based upon the selections carried out by the properly constituted Departmental promotions Committees and the based upon the assessment of merit of the respective candidates, no further action is needed or called for. On the contrary, if the respondent Corporation has not carried out such selections prior to granting promotions as Assistant Grade II/Accountant Grade II and Assistant Grade I/Accountant Grade I, the same shall be carried out immediately. The selections will have to be carried out on the basis of the availability of vacancies in a particular year.*

*If any revision of promotions/seniority is required to be undertaken, the same be carried out within a period of six (6) months from today. If on other hand, no such revision is called for the same may be communicated to all those concerned including the writ petitioners herein by publishing the detailed order drawn in the regard on the Notice Board of the Corporation."*

WHEREAS, in order to finalise the seniority list of Accountants Grade - I and AM (Accts.) keeping in view of objections raised by some of the Accountants Grade I and AM (Accts.) and also judgement now given by the Hon'ble High Court, seniority list of all the accountants both ESCOM & CSC since 1980 in the cadre of Acct.Gr-III and in the cadre of Acct.Gr-II (after the merger of ESCOM into CSC) & in the cadre of Acct. Gr-I is prepared based on the record which is detailed below.

Vide Procdgs.No.APSECCL/Estdt./B1/80/87, Dt.09.07.1987, probation of following (27) Accountants Grade III belonging to the erstwhile ESCOM was declared.

WHEREAS, Sri A.Ravindranath, AM (Accts.), Head Office vide his representation dated.24.07.2013 raised the following objection;

"As per the GO.No.61 & 143, the existing cadre of the employees at the time of merger should be taken into consideration for finalisation of seniority, whereas the employees at serial no.10, 13 & 16 have been placed of me in the present seniority list of AM (Accts.), with deviation from the seniority list of Accountants Grade I dt.05.07.2008. At the time of merger, myself and the above employees were mentioned in the cadre of Accountants Grade II and my position in the seniority list communicated by Head Office vide Procdgs.No.A2/2451/2008, dt.10.09.2009 was at serial no.52 and their position was 80,82 and 86 respectively. I submit my objection for having placed them ahead of me in the seniority list of AM (Accts.).

The Hon'ble High Court passed orders in WP.No.8216/2003 & WP.No.17122/2009 directing the Corporation that the employees regularised on 01.03.1984 cannot have a claim of seniority over the employees regularized on 08.10.1982, even though subsequently benefits were released by regularising the services from 08.10.82 at the later date. The order speaks "**By virtue of the regularisation of their services, they are entitled to count themselves as regular employees of the Corporation and even all other benefits, but they cannot steal a march in the seniority against those services are regularised earlier to them".**

While objecting the above, the said officer has informed that he deserves for placement of his seniority ahead of the three employees (namely Sri G.Sudheer Kumar Reddy, Smt.Ch.Kalpana & Sri M.Pratap Reddy) w.e.f. May, 2010 in the cadre of AM (Accts.) and considered the same based on facts.

WHEREAS, while examining the objection filed by Sri A.Ravindranath in the light of the above judgement, employees whose services were regularised retrospectively w.e.f.08.10.1982 have to be placed after the employees whose services were originally regularised w.e.f. 08.10.1982. As a result, the seniority of Grade III Accountants in ESCOM and CSC will be as follows:

WHEREAS, in the tentative seniority list communicated in the cadre of Acctt.Gr.I vide Procdgs.No.P.Admn.A2/2451/2008, dated.05.07.2008, seniority of Sri G.Sudheer Kumar Reddy, Smt.Ch.Kalpana and Sri M.Pratap Reddy was fixed in Sl.No.70, 72 & 76 respectively. After receipt of said seniority, certain employees submitted their objections to the seniority list in the cadre of Acctt.Gr.I. Among them, Sri M.Pratap Reddy, Acctt.Gr.I raised an objection stating that his services were regularised wef.08.10.82 and his seniority should be fixed accordingly.

WHEREAS, the services of Sri M.Pratap Reddy alongwith Sri G.Sudheer Kumar Reddy and Smt.Ch.Kalpana were regularised retrospectively w.e.f. 08.10.1982 as per directions of Hon'ble Court, their seniority was fixed in the cadre of Gr.III initially. Based on the revised seniority in the Grade III cadre, their seniority was re-fixed w.e.f. 10.07.19.87 as the notional date of promotion to the cadre of Grade II though the above three employees were promoted to the cadre of Grade II on 26.06.1989 and Grade I on 30.12.2005. Similarly, their seniority was also re-fixed in the cadre of Grade I based on date of their joining on daily wages, as all of them got promoted to the care of Acctt.Gr.I on 30.12.2005. As a result, the above mentioned three employees who were originally regularised w.e.f. 01.03.1984 and subsequently regularised retrospectively w.e.f.08.10.82 as per Hon'ble Court directions, though they were at the bottom of the actual seniority based on the record of regularisation of employees of both ESCOM and CSC in the cadre of Acctt.Gr.II, their seniority was positioned above in the ladder of sequence in the final seniority list of Acctt.Gr.I which was communicated vide Procdgs.No.P.Admn.A2/2451/2008, dated.28.07.2009. Based on the said final seniority list of Acctt.Gr.I, the above three employees were moved ahead of others in the panel of AM (Accts.) who were already seniors to them.

WHEREAS, as per judgement, seniority of existing Accountants (after deleting expired and retired employees) in the cadre of Grade I will be as follows:

WHEREAS, as seen from the above seniority which is prepared based on their original date of regularisation (not taken retrospective regularisation) , there is no justification on the objections raised on tentative seniority list communicated on 01.07.2013, since their positions stands good based on record. Further, employees from S.No.1 to 27 in the said seniority list, got promotions from Grade I to higher cadre, except employees at S.No.13, 16, 18 & 25.

WHEREAS, Sri G.Sudheer Kumar Reddy and Smt.Ch.Kalpana filed W.P.No.18450 of 2008 and WP.No.18456 of 2008 in the Hon'ble High Court for being considered for promotion from Acctt.Gr.I to Asst.Manager (Accts.) with seniority on par with employees promoted from Grade III to Grade II in 1987 and interim directions of Hon'ble High Court in **WPMP.No.24009 of 2008** in WP.No.18450 of 2008 and **WPMP.No.24022 of 2008** in WP.No.18456 of 2008 filed by Sri G.Sudheer Kumar Reddy, Acctt.Gr.I and Smt.Ch.Kalpana, Acctt.Gr.I reads as follows:

"There shall be interim direction to the 1<sup>st</sup> and 2<sup>nd</sup> respondents to consider the case of the petitioner for promotion to the post of Asst.Manager alongwith respondent no.3 and 4, strictly in accordance with seniority and the rules applicable to them, within a period of four weeks form the date of receipt of a copy of this order and communicate the same to the petitioner".

WHEREAS, as per interim directions and based on objection raised by Sri M.Pratap Reddy, seniority of Sri G.Sudheer Kumar Reddy, Smt.Ch.Kalpana and Sri M.Pratap Reddy was re-fixed in Gr III, Grade II and Grade I cadre in view of their date of joining on daily wages. By virtue of re-fixation of seniority in respect of Sri G.Sudheer Kumar Reddy at

S.No.17, Smt.Ch.Kalpana at S.No.19 and Sri M.Pratap Reddy at S.No.24, vide Procdgs.No.P.Admn.A2/2451/2008, dated.28.07.2009 in the cadre of Grade I, they moved ahead in the panel of Acctt.Gr.I and got promotions to the next higher cadre i.e., A.M.(Accts.) during the year 2010, which they should actually get it in the present panel year i.e. 2013.

WHEREAS, in light of the above judgement, the said three employees whose seniority was re-fixed in three cadres i.e. Gr.III, Gr.II and Gr.I though they were regularised w.e.f. 08.10.1982 retrospectively instead of 01.03.1984 which is against the common judgement given in the said WP. No.8216 of 2003 and 17122 of 2009. Further, the said three employees have not been come into the Zone of Consideration in the panel of Accountant Grade I for the promotion to the cadre of AM (Accts.) had their seniority not been re-fixed at Grade III, II and Gr.I level.

WHEREAS, in order to implement the above judgement which is the latest order regarding regularisation of services of employees of the Corporation, seniority of Sri G.Sudheer Kumar Reddy, Smt.Ch.Kalpana and Sri M.Pratap Reddy is revised and placed them at the bottom of employees who were originally regularised w.e.f. 08.10.1982 and placed them at an appropriate position alongwith the employees who were regularised w.e.f. 01.03.1984 originally.

WHEREAS, in pursuance of the revised seniority and according to the latest judgement in WP. No.8216 of 2003 and 17122 of 2009, Sri G.Sudheer Kumar Reddy, Smt.Ch.Kalpana and Sri M.Pratap Reddy will not come in the Zone of consideration up to the panel year 2013 for being promoted to the cadre of A.M.(Accts.). Hence their promotion w.e.f.29.05.2010 is no longer valid and they have to be reverted to the cadre of Acctt.Gr.I. However, these employees will be in the Zone of consideration only in the panel year 2013, the DPC which was convened on 23.08.2013.

WHEREAS, the above three individuals got their promotions as AM (Accts.) on 29.05.2010 instead of November, 2013 due to re-fixation of their seniority as per interim directions of Hon'ble High Court. Now, as per the final judgment in W.P.Nos.8216 of 2003 and 17122 of 2009, they should be considered for promotion to the cadre of AM (Accts.) only during the month of November, 2013 i.e. present panel year instead of 29.05.2010.

WHEREAS, tentative Seniority list of Accountant Grade-I (which was communicated vide procdgs., dated.01.07.2013) duly including the names of Sri G.Sudheerkumar Reddy, Smt.Ch.Kalpana and Sri M.Pratap Reddy as per Roster will be as follows :

WHEREAS, Sri G.Sudheer Kumar Reddy, Smt.Ch.Kalpana and Sri M.Pratap Reddy got promoted to the cadre of AM (Accts.) on 29.05.10 due to re-fixation of their seniority in the cadre of Accountant Grade I vide Procdgs.No.P.Admn.A2/2451/2008, dated.28.07.2009. Whereas, as per said judgement, they will come in the Zone of Consideration in the panel of 2013 only. Accordingly, their seniority has been fixed in the final seniority at an appropriate place.

WHEREAS, against (5) AM (Accts.) who filed objections against placement of seniority of Sri G.Sudeer Kumar Reddy, Smt.Ch.Kalpana and Sri M.Pratap Reddy, the seniority of the following A.M.(Accts.) is revised in accordance with directions of Honble' High Court directions in common judgement in W.P.No.8216 of 2003 and 17122 of 2009 Dt.24.07.2012.

WHEREAS, regarding Sri A.Ravindranath and Sri L.Nageswara Rao, though seniority of the Accountants revised in the cadre of Gr.III, II and I, date of promotions of these two individuals remains as it is. Though the said employees were promoted to the cadre of Grade II on 26.06.1989 and Grade I on 30.12.2005, based upon the revised seniority in the cadre of Acct.Gr.II, their seniority was also re-fixed with 10.07.1987 as the notional date of promotion to the Grade II cadre. In the cadre of Acct.Gr.I also, their seniority was fixed as per re-fixed seniority in the cadre of Acct.Gr.II and roster point.

**II)** WHEREAS, the following (3) employees have raised their objection on placement of employees belonging to SC/ST before them who were promoted in the cadre of A.M.(Accts..) after their joining on promotion, in the tentative seniority list due to extending the benefit of roster point at the time of fixation of seniority.

1. Smt Ch.Kalpana, A.M.(Accts.), F&IA Section, H.O
2. Sri N.Prasada Rao, the then A.M.(Accts.), F&IA Section, H.O
3. Sri A.Bikshapathi, A.M.(Accts.), D.O. Kurnool

WHEREAS, Government in G.O.Ms.No.2, Social Welfare (SW.ROR1) Dept., dated: 09.01.2004 has issued certain guidelines in implementing rule of reservation in promotions in respect of SC and STs. The said G.O., reads as;

***"Carry forward vacancies: Regarding carry forward of vacancies, if no qualified candidates are available, the following procedure shall be followed.***

**In case qualified Scheduled Caste/Scheduled Tribe candidates are not available for a particular panel year the vacancy shall be carried forward to the subsequent year. In the second year if Scheduled Caste/ Scheduled Tribe candidates are not available, the vacancies or points meant for Scheduled Caste/Scheduled Tribe candidates may be filled up by candidates from the feeder category based on merit and seniority. The number of such vacancies meant for Scheduled Caste and Scheduled Tribe should be carried forward and filled up first in the immediate subsequent year with Scheduled Caste/Scheduled Tribe candidates".**

Accordingly, the Corporation is following rule of reservation in considering promotions from the year 2005 onwards. Since there are carry forward vacancies belonging to SC/ST as per roster, the same are being filled-up with candidates belonging to SC/ST category from feeder cadres. Thus, the slots allotted to SC/ST in roster, were filled with SC/ST candidates. Based on the slots given to employees belonging to SC/ST category as per rule of reservation, the said seniority list was prepared and communicated, which does not effect the panel of particular category while considering promotions as the promotions are being effected as per eligibility of employees in their present category.

WHEREAS, the above mentioned three employees raised objection that their seniority is fixed below their juniors Sri.G.Rajender, Sri.P.Gopal, Smt.M.Saritha Vani and Smt K.Manju Bhargavi who were promoted two years later. They requested to place their seniority duly taking into consideration of their date appointment in the cadre.

WHEREAS, the employees against whom objections were raised by the above three employees belong to SC/ST categories. Their placement in the seniority list is as per Roster Points by following Rule of Reservation and conferred placements accordingly. Hence they have taken precedence over Smt Ch.Kalpana, A.M.(Accts.), F&IA Section, H.O, Sri N.Prasada Rao, the then A.M.(Accts.), F&IA Section, H.O, Sri A.Bikshapathi, A.M.(Accts.), D.O. Kurnool who belong to OC Category. In the approved panel of (5) Acct.Gr.I for promotion to the post of A.M.(Accts.) four (4) candidates belong to the SC category in which carried forward vacancies were available at the time of effecting promotions.

WHEREAS, as seen from the above objections, the roster points were allotted to the above employees based on their category which were vacant at the time of their promotion to the present cadre. Though as per G.O.Ms.No.143, CA, F & CS (CS-I) Dept., dated.27.10.2005, the date of joining in the cadre will be the main criteria along-with other parameters for considering an employee for promotion upto the level of Asst.Manager, from 2005 onwards, Rule 18(a) of APSCSCL Service Regulations, "**The SENIORITY of a person in a service shall, unless he has been reduced to a lower rank as a punishment, be determined by his placement in the list of selection, if he is a direct recruit and by his placement in the approved panel for promotion, if he is a promote**" is being followed in all cases and seniority is fixed accordingly follwoing the rule of reservation as per G.O. Ms.No.2. However it does not effect the panel of particular category while considering promotions as the promotions are being effected as per eligibility of employees in their present category.

WHEREAS, in view of the above the objection raised by the above three officers based upon date of joining and their placement as per roster point, at the time of fixation of seniority does not merit any consideration.

**III] WHEREAS, Sri A.Bikshapathi, A.M.(Accts.), has stated that due to minor supervisory lapse , during his tenure as A.M.(Accts.) FAC in DMO Sangareddy a disciplinary case has been instituted. As a consequence, he had to forgo his promotion and also placement in the seniority list. He pointed out that Sri P.Rama Goud, Ex.Asst.Gr.I is a main culprit who has been exonerated and action was dropped against him. Now he requested to consider and restore his placement in the seniority list.**

WHEREAS, the appeal preferred by the individual has been examined by the appellate authority basing on the merits and grounds of appeal put forth by the individual and has been rejected. His seniority has been fixed at an appropriate place. Thus there is no merit in the objection filed by Sri A.Bikshapathi, A.M.(Accts.), D.O. Kurnool.

WHEREAS, after issue of tentative seniority list, certain officers have retired or promoted to higher cadre and as such their names have been removed in the final list now being communicated. Similarly certain employees were promoted to the present cadre of A.M.(Accts.) and their names have been included in the final list at appropriate places as per the applicable rules.

AND WHEREAS, after taking into consideration the objections and modifications made thereon, the final seniority list of A.M.(Accts.) in terms of APSCSCL Recruitment & Service Regulations and as per Roster & Rule of Reservation is hereby communicated.

The General Managers/District Managers/Zonal Managers concerned are requested to communicate the said seniority list to the officers concerned and furnish the served copies of seniority list to Head Office immediately.
