2. Objection received from certain Assistants Gr-II.

In the reference 1st read above, tentative seniority list of Assistant Grade -II in terms of APSCSCL Recruitment and Service Regulations and as per the roster and rule of reservation was communicated to all the individuals shown in Annexure enclosed, calling for objections if any with due supporting evidence/documents. The following objections were received regarding the tentative seniority list of Assistants Gr-II.

1. Sri V.V.S Prasad, Asst.Gr-II, DO, Vijayawada:

He is ranked at sl.no.48 in the tentative seniority list. His objection is that, Smt. R.Nagamalleswari & Sri K.Nagulu placed at sl.nos 39 & 45 respectively in the tentative seniority list though they were promoted as Asst.Gr-II in June, 2010 i.e. after 41/2 years of his promotion as Asst.Gr-II. Further, His another objection is that, the above two individuals have already claimed the benefit of roster point at the time of promotion to the cadre of Grade-II by virtue of community/roster point, once again the benefit of community / roster point has been extended to them and were placed above him though they were juniors.

Government in G.O.Ms.No.2, Social Welfare (SW.ROR1) Dept., dated: 09.01.2004 has issued certain guidelines in implementing rule of reservation in promotions in favour of SC and STs. In the said G.O., it was mentioned that

"Carry forward vacancies: Regarding carry forward of vacancies, if no qualified candidates are available, the following procedure shall be followed.

In case qualified Scheduled Caste/Scheduled Tribe candidates are not available for a particular panel year the vacancy shall be carried forward to the subsequent year. In the second year if Scheduled Caste/ Scheduled Tribe candidates are not available, the vacancies or points meant for Scheduled Caste/Scheduled Tribe candidates may be filled up by candidates from the feeder category based on merit and seniority. The number of such vacancies meant for Scheduled Caste and Scheduled Tribe should be carried forward and filled up first in the immediate subsequent year with Scheduled Caste/Scheduled Tribe candidates".

Accordingly, rule of reservation is followed in the Corporation in considering promotions from the year 2005 onwards, since there are carry forward vacancies belongs to SC/ST as per roster, the same vacancies are being filled-up with candidates belongs to SC/ST community from feeder category. Thus, the slots allotted to SC/ST in roster, were filled with SC/ST candidates. Based on the slots given to employees belonging to SC/ST as per rule of reservation, the said seniority list was prepared and communicated, which does not effect the panel of particular category while considering promotions as the promotions are being effected as per eligibility of employees in their present category.

Sri V.V.S. Prasad, DO, Vijayawada, has raised objection on the following 2 employees who were promoted in the cadre of Asst.Gr-II after his joining on promotion were placed before him in the tentative seniority list due to extending the benefit of roster point at the time of fixation of seniority.

1. R.Nagamalleshwari sl.no.39 2. K.Nagulu sl.no.45

Sri V.V.S. Prasad, DO, Vijayawada has been placed at roster point 237 in the category of Asst. Gr-II, where as roster points allotted to the above individuals are

1. R.Nagamalleshwari 225 (ST) 2. K.Nagulu 233 (ST)

The roster points were allotted to the above employees based on their community which were vacant at the time of their promotion in the present cadre. Though as per G.O.Ms.No.143, CA, F & CS (CS-I) Dept., dated.27.10.2005, the date of joining in the cadre will be the main criteria along-with other parameters for considering an employee for promotion upto the level of Asst.Manager, from 2005 onwards, as per staff regulations section 18(a) of APSCSCL, "The SENIORITY of a person in a service shall, unless he has been reduced to a lower rank as a punishment, be determined by his placement in the list of selection, if he is a direct recruit and by his placement in the approved panel for promotion, if he is a promote", we are taking consideration of placement based on position of the employee in their respective panel and also rule of reservation as per G.O. Ms.No.2 in fixation of seniority. Therefore, objection raised by the individual on date of joining of the above (2) employees who were promoted in the cadre of Asst.Gr-II after his joining on promotion has no merits for consideration.

2. Sri J.Bhaskara Rao, Asst.Gr-II, ZO, Kakinada:

He is ranked at sl.no.6 in the tentative seniority list of Asst.Gr-II. His objection is that, employees placed from sl.no 85 to 101 in Assistant Grade-I tentative seniority list are juniors to him, and requested to consider extending the benefit of promotion as Asst.Gr-I duly revising seniority.

It is to inform that, the individual was placed under suspension on 22.5.2007 by JC&EOED, Adilabad for his proved misconduct of changing his religion and name as Mohd. Salman without prior intimation to the competent authority and contracting bigamous marriage when the first wife is alive. He was re-instated into service on 31.07.2008 pending finalization of disciplinary proceedings. A P.C.O was issued to him proposing punishment. Against P.C.O he filed W.P. before Hon'ble High Court, which is pending. Since, he involved in disciplinary case, his objection in this regard has no merit for consideration.

3. Smt.R.Nagamalleshwari, Asst.Gr-II, DO, Krishna:

She is ranked at 39 in the tentative seniority list. Her objection is that, she belongs to ST category and as per roster ST category comes under serial number 8, and she is the first senior person in the list of Asst.Gr-II in the ST category.

It is to inform that, the said seniority list is prepared and communicated is as per the roster only. When promotions were affected, roster point 208 (ST) in the cadre of Asst.Gr-II was already filled up, next roster point 225(ST) was vacant, accordingly the individual was placed at roster 225(ST). Hence, her objection merits no consideration.

4. B.Eswara Rao, Asst.Gr-II, DO, Srikakulam:

The individual has raised objection on caste and requested to rectify his caste as BC-A instead of BC.

It is to inform that, roster points are categorised into SC, ST & OC, and all the backward classes comes under the category of OC only. Hence, the objection raised by the individual merits no consideration.

Taking into consideration of the above, final seniority list of Assistant Grade-II is prepared and communicated now.

General Manager (Finance), Head Office and District Managers concerned are requested to communicate the said seniority list to the employees concerned working under their control. They are also requested to furnish the served copies of seniority list to Head Office immediately.
