In the reference 3^{rd} cited, orders were issued provisionally allocating the officers, staff & class-IV employees working in Head Office of united APSCSCL between the two States i.e. AP and Telangana in the ratio of 58.32:41.68 as per guidelines received from the Government vide references 1^{st} & 2^{nd} cited.

At the time of proposal of the said allocation orders, Sri M.Suryanarayana Raju, Tech.Work Inspector Gr.III, Head Office was in service and is retiring from service on 31.05.2014 on attaing the age of superannuation. Hence, his name is now deleted from the employees list at Head Office. Further, against 105 available posts (employees) at Head Office in all cadres, 61 employees will be allotted to the State of AP as per ratio of 58.32 and 44 employees will be allotted to the State of Telangana in the ratio of 41.68. But, due to division of posts in each cadre in the said ratio, 63 employees for AP and 42 employees for Telangana got allotted in the proceedings 3rd cited.

Most of the procurement under DCP and almost entire paddy procurement is in Telangana State. As such, it is decided to allot the single post of TA.Gr.I to the Telangana State. Similarly, about 60% of the civil works are being undertaken in Telangana only. Hence, it is decided to allot the post of Executive Engineer to the Telangana State.

Accordingly, in modification of orders earlier issued vide reference 3^{rd} cited, the following orders are hereby issued.
