Sub:-APSCSCL-HO-Finance & Accounts- Purchase of Red gram Dall by District offices-Imposition of Quality cuts-certain instructions on booking of purchases and VAT on Red gram Dall from April 2013 -Reg.

The District offices are purchasing Red gram Dall every month from suppliers within the State and from outside the State as per the Tenders finalized by the Head office. In the transaction quality cuts are imposed towards unhusked and other unsound grains and recovered from the cost of Dall by paying net amount.

In this connection the following instructions are issued regarding treatment of the transaction in accounts and for submission of VAT returns,

- 1. The net purchase cost of Dall after deduction of Quality Cuts shall be entered in OE IV. Presently some district offices are entering the gross value in OE IV under purchases and crediting the amount of Quality Cuts to "Income from Quality Cuts A/C" VAT is being paid on gross value of purchases. Such practice is creating problems at the time of VAT Assessment. Hence the net purchase cost shall be booked in OE IV as purchases w.e.f <u>April 2013.</u>
- 2. VAT shall be calculated and paid to the Supplier, only on the net purchase cost after deduction of Quality Cuts @5%. If VAT was paid at any time on the gross purchase value, such excess payment shall be recovered from the supplier.
- 3. The net purchase value as above and VAT thereon shall be entered in OE IV and reported in monthly VAT returns. The net average rate per MT shall be shown in the return

4. The monthly VAT return shall be supported by the details of quality cuts made during the month in annexure IV in the following proforma
