Sub: APSCSCL-Pay Bills-Revision of D.A from 1st July 17-Payment of DA Arrears from July 2017 to August 2018 and Sept 2018 in cash-Reg.

In the reference cited, Government of Andhra Pradesh have issued orders revising the rates of Dearness Allowance to the State Govt.employees in Andhra Pradesh Revised Pay Scales 2015 from 24.104% of basic pay to 25.676% of the basic pay from 1st July 2017. It is decided to implement orders issued in the reference cited revision DA w.e.f July 17 to the Corporation employees and release arrears in cash w.e.f July 17 to August 18 and Sept 18 @ 1.572% on the basic pay.

In view of the enhancement of DA from 24.104% to 25.676%, all District Manager's and Zonal Manager's APSCSCL are hereby requested to revise DA from October 18 paybills onwards and draw the DA arrears from 1st July 2017 to 30th September 2018 @ 1.572% on the basic pay and make payment of arrears in cash.

Regarding the deputationists working in the Corporation, the DA arrears shall be drawn in terms of Para no.14 of the G.O. The revised D.A Arrears from the period 1st July 2017 to 31st August 2018 to be adjusted to the GPF Account. The Arrears pertaining to the month of September 18 shall be paid in cash. In the case of employees who are due to retire on or before 31st December 2018, the arrears of D.A shall be drawn and paid in cash.

Further, in respect of the employees who are appointed to Govt.service on or after 01/09/2004 and are governed by the Contributory Pension Scheme (CPS) in terms of Para no.14, out of the arrears payable for the period from 1st July 17 to 30th Sept 2018, 10% shall be credited to the PRAN accounts of the individuals along with the government share as per G.O.Ms.No.250, Finance (Pen. I) Dept.dt.06/09/2012 and the remaining 90% of arrears shall be paid in cash.

The IOCPF of DA Arrears (1st July 17 to 30th Sept 18) shall be sent to Head Office along with October 18 IOCPF. The DA Arrears bill is to be drawn to all those who are in the pay rolls during the period covered in G.O now communicated.
