Sub:- APSCSCL – Procurement of paddy under MSP operations during Khariff 2012-13 – Custom milling of paddy – Acceptance of custom milled raw rice from boiled rice mills – Reg.

In the reference 1st cited, the Government of Andhra Pradesh ordered that A.P. State Civil Supplies Corporation Ltd. shall make arrangements for procurement of paddy at MSP under decentralized procurement and retain the resultant CMR raw rice for utilization in PDS in the entire State and deliver the boiled rice under CMR to FCI for the Central Pool.

Accordingly, vide in reference 2nd cited, it was requested to accept custom milled raw rice and make necessary arrangements to receive raw rice under CMR.

So far in Khariff 2012-13, 6.5 LMT of paddy is purchased by the Corporation under MSP operations and delivered for custom milling. The resultant CMR to be delivered by the rice millers is 4.25 LMT. However, the rice millers have delivered 0.08 LMT of CMR. Out of which raw rice delivery is 0.05 LMT only. Much against the Governmental instructions vide reference 1st cited, the rice millers are not delivering CMR in time bound manner. In delivery of CMR, allegations are that the rice millers are utilizing the CMR paddy for delivery of raw rice to FCI under levy operations. The District Manager is not insisting for delivery of CMR though he is responsible. From hereafter the responsibility is fixed on the District Manager to see that the CMR is delivered within 2 months time after delivery of CMR paddy to rice millers.

I therefore request the District Managers to see that all rice millers receiving paddy during Khariff shall deliver raw rice to Civil Supplies Corporation in the State within 2 months time after delivery of CMR paddy. The respective Joint Collectors are requested to review CMR delivery on weekly basis and report.
