Vide reference 1st cited, Revised Roaster Panels for the years 2018, 2020 and from 2020-21 to 2024-25 of all cadres of employees of ASPCSCL, were communicated on 01.12.2025 and objections called for, with a direction to submit the representations/objections, if any, with due supporting evidence/documents, to reach the Head Office on or before 10 days.
