

#### INTRODUCTION:

In pursuance of the approval of Government of Andhra Pradesh and instructions of the Commissioner of Civil Supplies & EO Secretary, CA F&CS Dept, it is proposed to procure 50,000 Tarpaulins across the state during KMS 2025-26 to protect paddy stocks from unseasonal rains and to ensure maintenance of FAQ Standards during procurement operations at Rythu Seva Kendras (RSKs). Out of which the districts are allowed to procure 30,000 tarpaulins and position at RSKs across the state. Among the 30,000 tarpaulins, allocation made to BAPATLA District is 1,100 tarpaulins.

Technical Specifications of the Tarpaulins are as follows: Guage: 250 GSM (UV stabilized quality) in Sizes: 24'x18 and 30'X30'.

The A P State Civil Supplies Corporation Limited (APSCSCL) Bapatla District have invited eauction for Empanelment of Agency for supply of gauge: 250 GSM Tarpaulins (UV - Stabilized quality).

- 1. Number of Tarpaulins of size 24'x18' - 550.
- **2.** Number of Tarpaulins of size 30′x30′ - 550.

APSCSCL shall follow district wise online e-auction mode and has entrusted the same to NCDEX e-Markets Ltd. for conducting electronic reverse auction for supply of Tarpaulins in Technical Specifications as mentioned above to the locations mentioned in Annexure - I.

Procurement utilization and payment procedure of Tarpaulins stipulated in the circular are as follows:

- The District Purchase Committee (DPC) shall finalize the Rythu Seva Kendra (RSK) -wise requirement of tarpaulins, float tenders, and appoint suppliers for the purchase of the allocated quantity of tarpaulins, duly following the prescribed procurement procedure.
- The DPC shall oversee the receipt, inspection, storage, and distribution of tarpaulins at the designated RSKs, ensuring that all supplies conform to approved quality standards.
- Tenders should be called for supply of tarpaulins up to the identified designated locations godowns/PPCs. (Annexure - I enclosed).
- Quality Testing: Lot-wise pre-supply and post-delivery testing shall be conducted as per the norms prescribed strictly conforming to BIS and departmental quality standards. Any consignment failing to meet specifications shall be rejected and replaced by the supplier at their cost.
- The procured tarpaulins shall remain under the custody of the Agricultural Marketing Department. Proper stock and issue registers shall be maintained by the designated custodian officer under the supervision of the District Agri Trade & Marketing Officer.
- The tarpaulins shall be issued to farmers free of cost to facilitate drying and protection of paddy from unseasonal rains. Farmers shall return the tarpaulins after use to the concerned custodian officer for reuse in subsequent procurement seasons.

- The DPC shall ensure wide publicity regarding the availability and use of tarpaulins through local media, village-level announcements (tom-tom), and display boards at RSKs.
- Supplier claims shall be obtained only after completion of supply, verified against the acknowledgements issued by RSK staff.
- The expenditure shall be met either from the District Disaster fund or Market Fee accruals payable to the Agricultural Marketing Department, to be adjusted by APSCSCL.
- In case the expenditure is met from the District Disaster Fund, the supplier bills shall be processed and settled at the district level after due verification.
- In case the expenditure is met from Market Fee accruals, the verified claims shall be forwarded to the Head Office, APSCSCL, for payment and adjustment against the Market Fee payable to the Agricultural Marketing Department.
- The tarpaulins shall be treated as departmental assets, maintained under the custody of the District Agri Trade & Marketing Officer. These shall be periodically inspected and re-used in subsequent procurement seasons.
- The supplying agency shall bear expenditure, for transportation and supply of tarpaulins to the designated locations.

## Quality Determination

- The quality of tarpaulins shall be determined based on movement orders issued by the DPC.
- The supplying agency shall strictly adhere to the timelines for delivery of Tarpaulins as per the quantity communicated.

In order to facilitate Agency to participate in NCDEX\_e-Markets Limited process, registration with NCDEX e-Markets Ltd. is mandatory.

## 1. <u>ELIGIBILITY/PRE QUALIFICATION CONDITIONS.</u>

- i. Tenderer shall be a firm (or) registered company (or) Cooperative society (or) any legal organization.
- ii. The Agency/Packer shall possess valid GST registration issued by concerned authorities.
- iii. The firm/applicant should not have been Black-listed/convicted for any offence(s) or violation of any State or Central act such as Essential Commodities Act etc or any criminal offence under IPC.
  - a. The Applicant may also be directed to furnish additional information/confirmation in connection with verification of the documents submitted by the Applicant, if deemed necessary, at the sole discretion of APSCSCL.



- b. APSCSCL reserves the right to accept or reject any of the bids without assigning any reasons whatsoever. The decision of Joint Collector & EOED, APSCSCL in this regard shall be final and binding on all participating bidders.
- iv. The Agency shall ensure compliance of all government legislations, policies, guidelines, orders etc. related to any or all of the above activities.
- v. The Agency shall undertake to abide by the statutory requirements and guidelines of the State Government from time to time.
- vi. Tenderers those are blacklisted/debarred/Banned/Suspended by APSCSCL/Legal Metrology Dept./by any other Dept of AP State is ineligible to participate in the tenders during the period of such debarment or for a period of two years from the date of debarment, whichever is earlier.
- vii. If any person/Firm/Company who has been blacklisted files a Tender in a benami name his tender stands summarily rejected apart from forfeiture of EMD furnished. If it comes to notice after award of contract also, the contract will be cancelled and the agency will be black-listed for a period of two years apart from forfeiture of EMD/Security Deposit. In such cases, the tender may be awarded to the L2 tenderer at L1 rate if the L2 tenderer is willing. Else, the APSCSCL can undertake departmental packing at approved L1 Rate only.
- viii. Any Tenderer whose contract with the APSCSCL or any other Govt./Private organization has been terminated for violation of terms and conditions of the contract before the expiry of the contract period at any point of time during last two years, will be ineligible.

# 2. DOCUMENTS TO BE FURNISHED ALONG WITH APPLICATION FOR PARTICIPATION.

- I. The Tenderer shall submit attested copy of Audited Profit & Loss Account, Balance Sheet and the Income Tax returns of last Three Financial Years (2022-23, 2023-24, 2024-25) with a copy of a PAN card attested by authorized signatory.
- II. Self-Attested copy of Certificate of registration under GST (Goods and Service Tax) as applicable.
- III. In case of partnership firm or Co-operative or Corporate, the Agency/Packer should furnish a copy of the partnership deed or bylaw or Memorandum of Association & Articles of Association as the case may be.
- IV. The Tenderer shall furnish letter of authority or power of attorney for having authorized the person to sign the documents on behalf of firm or society or body corporate.
- V. The address proof of the authorized signatory viz., Telephone bill/copy of pass port / electricity bill/voter ID proof should be submitted along with the application
- VI. Bank account details of firm along with IFSC code, Branch details, address shall be furnished in the letterhead of the firm or Cancelled Cheque.
- VII. All the pages of the RFP document shall be signed by tenderer or authorized person before submission of tender. The tender submitted along with confirmation deemed that the tenderer is aware and understood all the terms & conditions of this tender document.

## 3. SCHEDULING OF E-AUCTIONS.

Based on the requirements, the APSCSCL through their Office will notify NCDEX e\_Markets Ltd to schedule auctions. Further such details will be posted on the website of APSCSCL. Neither the APSCSCL nor NCDEX e Markets Ltd will individually intimate to the registered participant regarding the e-auction schedule.

#### 4. EVALUATION OF APPLICATION:

- i. The completed applications along with relevant documents and fee / registration charges shall be submitted on or before \_\_05.11.25 @5PM\_ at the following mail ID: apreg@neml.in.
- ii. Eligible Participants will be issued with User ID and Password by NCDEX e MARKETS LTD after completion of the registration.
- iii. Registered Participants whose Technical bids are qualified, are eligible to participate in electronic bidding system (e-auction) for packing of Rice conducted by NCDEX e-MARKETS LTD as and when scheduled.

# 5. PROCESS OF ELECTRONIC AUCTION SYSTEM ON NCDEXe MARKETS LTD PLATFORM.

- i. The Corporation will conduct financial auction on <a href="https://trade.neml.in">https://trade.neml.in</a> (e-auction platform). The e-auction will be conducted district wise and the details are mentioned in Annexure-II. The system time of NCDEX e MARKETS LTD portal will be considered to start and to end the e-auction.
- ii. The technically qualified tenderers are eligible to participate in e-auction.
- iii. The Corporation organizes the e-reverse auction based on the L1 rate received in the Page 7 of 16

tender.

- iv. Any changes made in the time schedule will be intimated to all the participants by publishing the same in the websites of APSCSCL and NCDEX e MARKETS LTD website.
- v. The tenderer shall take adequate care and is solely responsible to obtain details of the schedule of e-Auction through the websites in their own interest, rather than depending on other mode of information sources.
- vi. The bidder can modify his bid as many number of times as possible till the closing time of e-auction subject to overall reduction in the price. The system time of NCDEX e MARKETS LTD plat form will be considered to start and end the e-auction.
- vii. However, the auction platform will not allow the bidder to modify his bid to increase the price. In case of such modified bids, the same shall be rejected and the earlier valid bid prevails.
- viii. In case of two or more bidders emerge as lowest with identical prices after conclusion of e-auction, bidder who puts in his bid first on e-auction platform gets priority and considered as lowest.
- ix. The bids submitted after the closing time of e-auction will be rejected by the system.

- 3 Supply of Tarpaulins inclusive of all taxes & duties, levies, and applicable GST if any & all related transport expenses till delivery. A Group Reverse Auction will be conducted for the tentative quantity of District-wise.
- x. The price quote shall be in Rupees per 1 (One) Tarpaulin only for all slabs in the Group.
- xi. The reducing tick size shall be Rs. 5/-. (Rupees Five only) per quantity.
- xii. The price bid for providing rates shall be quoted in Indian Rupees per Quintal. The rate shall be quoted for all the slabs. The L1 bidder will be finalized basing on the weighted average rate quoted for corresponding quantities on the least cost basis. Failure to quote for all the slabs in respect of a Group will result in the rejection of the bid by the online electronic platform.
- xiii. The details of the tentative quantity in respect of each slab available for submission of bid rates will be provided. The bidding process for each slab is subject to the following conditions for determining the lowest total cost of all slabs on the electronic auction platform.
- xiv. The bidder can modify their bid rate for each of the slabs in a lead for a particular lot put for e-Auction as many times as possible until the closing time of the e-Auction, subject to an overall reduction in total cost computed by the system for the Group.

- The auction platform will not allow the bidder to modify their bid once submitted to increase the total cost for the lot put for auction. If such modified bids are submitted, they will be rejected, and the earlier valid bid will prevail.
- xvi. There will be 3 (Three) extensions of 5 minutes each. Each Extension will come into effect, if any bid is received in the last 03 minutes of closing of the initial auction session or the extension session
- xvii. The bids submitted after the closing time of e-auction will be rejected by the system.
- xviii. The lowest valid bid received on the platform will be communicated to the APSCSCL by NCDEX e MARKETS LTD. The APSCSCL after evaluation of bids will communicate regarding acceptance/rejection of the lowest bid (if found not competitive). The lowest valid bid once approved by the APSCSCL will be declared as successful L-1 bidder and the same will be communicated by e-mail to the successful bidder through APSCSCL. The Corporation reserves the right, without giving any reason, to accept or to reject all or any bid including lowest bid.
- The final results of the E-Auction as approved by APSCSCL are binding on all xix. bidders. Any requests for cancellation of bids received either during the auction session or after the conclusion of an auction session shall not be accepted. Failure to accept award of supply contract by the successful Packing Agency shall result in the forfeiture of the EMD (Margin money).
- The Bids of all Bidders who have participated in the e-Auction must remain valid for minimum period of 90 (Ninety) working days from the date of auction or till the tender process is completed, whichever is later.
- xxi. The results of thee-Auction as approved by APSCSCL are binding on all bidders. Any requests for cancellation of bids received either during the auction session or after the conclusion of an auction session shall not be accepted. Failure to accept the contract by the successful tenderer shall result in the forfeiture of the EMD and blacklisting from further participation in the e-auctions for a period of two years. The decision of the Joint Collector & EOED, APSCSCL in this regard will be final.
- xxii. Any bid placed using the bidders username and the password shall be deemed to be an unconditional binding of the bidder to whom such user ID and the password has been allotted by ap NCDEX e-Markets Limited, inter-alia, for the purpose of the eauction and the bidder shall be solely and fully responsible for all the activities that occur under such user ID and password. The user is therefore advised to check the user ID and the pass word before thee-auction and is advised not to reveal it to anyone else to prevent misuse of the same. It is further suggested that the tenderers are requested to change the password frequently to protect from misuse.
- xxiii. APSCSCL/NeML shall not be responsible for any failure of power, Network, Server, Bandwidth problems, Hosting Server, Internet Connectivity, ISP or otherwise or the slowness to access NCDEX e-Markets Limited platform. In case if e-auctions cannot be held on scheduled date due to server problems, the same will be rescheduled and will be held on alternative day, the details of such date/s will be notified in the website of APSCSCL and NCDEX e MARKETS LTD site.

xxiv. The Invitation of Bids, the terms and conditions of thee-auction, Bid of the

- Successful bidder, Letter / Email Confirmation / Acceptance issued by the APSCSCL to the successful bidder along with any amendment issued prior to signing of contract shall constitute the Contract between the Corporation and the tenderer.
- xxv. The successful Tenderer will be intimated the acceptance of his tender by a letter / email. The Corporation reserves the right to reject any or all the tenders without assigning any reason.
- xxvi. In\_case of any clear indication of cartelization, the Corporation shall reject the tender(s), and forfeit the EMD.
- Annexure/Appendices is found to be false/incorrect at any stage, the Corporation shall have the right to disqualify/summarily terminate the contract, without prejudice to any other rights that the Corporation may have under the Contract and law.
- amount of tax, interest, penalty and litigation cost, if any, that may be incurred in future due to GST reporting/compliance mistake(s) on the part of the service provider.

## 6. EARNEST MONEY DEPOSIT:

- i. Every registered Participant will be provided with unique virtual account number by NeML. The registered Participant shall deposit 2.795% on price bid with the NCDEX e-Markets Ltd in to the provided Virtual Account to participate in the proposed auctions by way of RTGS or electronic fund transfer on or before e-Auction Starts.
- ii. The successful bidder is to pay transaction charges @ of 0.25% plus GST @18% on bid value thereon (i.e. 0.295% of price discovered value). The balance amount will be transferred to APSCSCL towards EMD.
- iii. The Tenderer shall be permitted to bid on the express condition that in case he modifies his offer, or terms & conditions thereof, after submitting his tender, for any reason whatsoever during the tender process, the Earnest Money Deposited by him shall stand forfeited, without prejudice to any other rights and remedies of the Corporation under the contract and law, and the Tenderer will be liable for any loss suffered by the Corporation on account of its withdrawal/modification etc besides forfeiture of EMD. He will also be debarred from participating in any other Tender with the Corporation for a period of two years.
- iv. Only the EMD (Margin Money) of the lowest bidder would be blocked by NeML. EMD (Margin Money) of the unsuccessful Bidder(s), including those whose bid(s) are not accepted due to non-fulfillment / not meeting the conditions attached to the bid(s), shall be returned by NCDEX e Markets on the withdrawal request made by the bidder latest by one day from the day of close of e-Auction.

iv No interest shall be given on the EMD.

## 7. SUBLETTING:

The Supplying Agency shall not sublet, transfer, or assign the Contract, or any part thereof.

## 8. LIABILITY OF PACKING AGENCY:

I. Without prejudice to the generality of the foregoing, in the event of failure/delay of the Agency to provide Tarpaulins as indented by the Corporation the Agency will be made responsible for the damages/losses suffered by the Corporation due to the delay/failure.

## 9. ORDER OF SUPPLIES:

- i. The successful bidders who qualify in e-auction will be issued with Work order by APSCSCL. The agency should supply tarpaulins within the prescribed time period mentioned in the work order.
- ii. Non acceptance of Work order bid within 3 working days of declaration of e-auction results will amount to forfeiture of EMD (Margin money) deposited and may face blacklisting from participating in the subsequent Tenders / e-auctions called by APSCSCL for a period of two years as per the discretion of Joint Collector & EOED, APSCSCL.

## 10. DOCUMENTS TO BE SUBMITTED BY PACKING AGENCYS FOR PAYMENT:

- i. The Packing Agency shall supply goods with good quality and quantity as entrusted by Corporation as per the movement orders issued by the District Civil Supplies Manager. The Agency shall submit the bills for the quantities delivered to the Corporation.
- ii. The Corporation will make payments of bills claimed subject to reconciliation of stocks supplied. The Corporations find the bills in\_order, payment to the tenderer will be done within 30 days from the date receipt of bills.
- iii. Applicable Statutory deductions like Service Tax, TDS (Income Tax) etc. will be deducted from the payments to the Agency as per rules in force.
- iv. The Corporation will not make any payment of interest on outstanding bills at any time.

## 11. VALIDITY OF BIDS:

The bids will be valid for a maximum period of **Ninety (90) Working days** from the date of conclusion of e-auction. APSCCL will communicate the acceptance or rejection of the bids within the above time frame.

## 12. DISPUTE RESOLUTION

- i. In case of any disputes relating to tender including the interpretation of any of the Clause/Clauses of the tender, the matter shall be referred to VC & MD, APSCSCL.
- ii. In case, if disputes are not resolved then them atter may be referred to Commissioner of Civil Supplies, Government of Andhra Pradesh who will be the appellate authority.

iii. In case of any disputes still not resolved and which are relating to under this Tender, including the interpretation of any of the Clause/Clauses of this Tender, the matter shall be referred to a sole arbitrator not less than the rank of Secretary to Government of Andhra Pradesh, appointed by the Government. The remuneration for the arbitrator shall be fixed by the Government. The arbitration shall be held in where Head Office of APSCSCL is situated and the decision of the arbitrator shall be final and binding on both parties to the arbitration.

#### 13. MISCELLANEOUS

## i) COMPLIANCE WITH DIRECTIONS:
